3. PLANNING

- a. Tree Works:
- At Rear of Mercers Hall, The Street: Roger Best had again stated that he was confident he had identified the correct trees, and had asked for one of the Councillors to meet him at the property. The Councillors present asked the Clerk to contact Suffolk Coastal and ask them to send the correct Officer to meet with Mr Best and provide a report to the Council.
